

# Bitwise 10 Crypto Index Fund (non-OTC Trust)

The Fund's principal investment strategy is to invest in a portfolio of crypto assets that seeks to track the Bitwise 10 Large Cap Crypto Index, a market-cap-weighted index of the 10 largest crypto assets. The Index has a public, formal methodology that includes eligibility rules meant to screen out certain critical risks around custody, liquidity, regulation, and other concerns. The Index is rebalanced monthly.

## Why Invest?

- Diversified Crypto Exposure.** The Fund provides a single point of access to gain exposure to the largest assets in the crypto market, screened for certain risks, without having to pick individual crypto assets.
- Subscriptions and Redemptions at NAV.** The Fund offers subscriptions and redemptions at its Net Asset Value (NAV) weekly. It will not pursue public market quotation. This eliminates complexities related to minimum holding periods, share transfers, and secondary market share price volatility.
- Institutional Custody and Security.** Custody is a critical component of crypto asset management. The Fund's assets are held securely with one of the world's leading crypto custodians.
