

# Bitwise BTC/ETH Equal Weight Strategy

The principal investment strategy is to invest in a portfolio of crypto assets that seeks to track the Bitwise BTC/ETH Equal Weight Crypto Index, an equal-weighted index of Bitcoin (BTC) and Ethereum (ETH). The Index is rebalanced quarterly.
